6. You have been assigned Locker No. _____ at the City of San Ramon Transit Center. This Agreement expires on _____ unless earlier terminated as set forth herein. Notice of expiration will be mailed to the renter approximately two weeks before the expiration date. The renter may renew the Agreement by filling out a new application form and paying the appropriate rental fee. The renter shall notify the City of San Ramon of any change in address.
7. The renter may terminate this Agreement before the expiration date by notifying the City of San Ramon Transportation office in writing, or in person, of intent to terminate.
8. Notwithstanding the City of San Ramon may, at any time, terminate this Agreement for violation of the terms.
9. Notwithstanding the City of San Ramon, upon 30 days prior written notice or, at its sole discretion, may refuse to renew this agreement upon its expiration.
10. Upon termination of the Agreement, the lock replacement deposit will be refunded upon return of the key. If the locker key is not returned to City of San Ramon upon 15 days of the expiration or termination of this Agreement, the City of San Ramon may recover possession of the locker, retain the deposit, and dispose of any property remaining in the locker in accordance with the law.
11. The undersigned represents that the locker will be used only for the storage of a bicycle.
12. **THIS AGREEMENT LIMITS OUR LIABILITY - READ IT CAREFULLY.** This Agreement entitles the renter to store one bicycle in the above designated locker for the time period indicated herein. **STORE BICYCLE OR MOPED PROPERLY AND LOCK LOCKER.** The City of San Ramon is not responsible for fire, theft, loss or damage to the bicycle or any other article left in the locker. Renter shall defend, indemnify and hold harmless the City of San Ramon and their directors, officers, agents, representatives and employees from any liability of any nature arising out of renter's use of the locker.
13. **The Undersigned waives any claim to the right of privacy and expressly consents to allow the City of San Ramon to open and inspect the locker and the contents thereof at any time without prior notice: in an emergency; to determine whether a health or safety hazard exist; or to determine whether any term of this Agreement is being violated.**

THIS CONSTITUTES THE ENTIRE AGREEMENT, AND EXECUTION OF IT CONSTITUTES ACKNOWLEDGMENT BY THE RENTER THAT HE/SHE HAS READ AND AGREES TO THE FOREGOING. THE PERSON SIGNING THIS AGREEMENT MUST BE 18 YEARS OF AGE OR OLDER.
